
## FOREWARD

*Law College Dehradun, as a flagship institution of Uttarakhand University under the aegis of Sushila Devi Centre for Professional Studies and Research was established in the year 2002, as the first independent Law College of Uttarakhand. The college was the visionary project of Shri Jitendra Joshi, then chairman of the college and present Chancellor of the Uttarakhand University along with his plenipotentiaries from across the academic spectrum. Within a short span of time, the college registered its reckoning presence, becoming one of the most sought after destination in the field of legal education. The college which was initially affiliated to Hemwati Nandan Bahuguna Garhwal Central University became a top-spot, producing a series of gold medalists and university merit holders. As luck would have it, LCD along-with its sister concerns Uttarakhand Institute of Technology and Uttarakhand Institute of Management reached its practical zenith with their merger in the form of Uttarakhand University in 2013 with the passing of Uttarakhand University Act, 2012.*






***Guest Lecture by Dr. Shamnad Basheer on “Emerging Trends of Intellectual Property Rights”***
