The first session focused on the orientation of the students in the establishment of their CVs as

The event was held in four easy and interactive sessions which included the stimulation of Model United Nations Conference and Youth Parliament, through the two mock sessions. More than 60

students participated in this training program.

The first session was held on 12th of February, 2019. It was mainly focused on introducing the students to Model United Nation Conferences and Youth Parliaments and to acquaint with the structure of UN Committees and Indian Committees. The students were inquisitive and enthusiastic to learn and made it an interactive session.

The second session of “CONNAÎTRE 2019” was held on the 15th of February, 2019. It aimed to teach students about the Rules of Procedure followed in different committees, Research Methodology and documentation.



The third session of the training program was held in two mock sessions on 18th and 19th of February 2019. The sessions

commenced with the felicitation of the moderators and an inspiring speech by our Honorable Dean Professor (Dr.) Rajesh Bahuguna. The first mock session was the simulation of a Model UN Conference which was moderated by Advocate Anjan Sahu. The Committee simulated was GA (DISEC) and the agenda of the conference was "International security in the light of information technology and cyber warfare." The second mock session was the simulation of a Youth Parliament which was moderated by Mr. Basuki Nath Pandey of ICFAI Law School, Dehradun. National Debate Competition: 3rd Edition of Concours De Debat, 2019

56 Participants Clash on Defense Indigenization!

On 29th March, 2019, Aarambh-The Debating Society of Law College Dehradun organized the 3rd Edition of Concours De Debat, one of the two major national events of Aarambh on the motion 'This House Believes That The Defense Indigenization Program does more Harm than Good'.

The Chief Guest of the event, Air Marshal Brijesh Dhar Jayal PVSM AVSM VM and Bar, an officer of the Indian Air Force, who served in the appointment of Air Officer Commanding-in-Chief of the South Western Air Command from 1992 to 1993,

Suggested that privatization of the Defense Indigenization program would be the answer to the problems that the program is facing in status quo. Speakers speaking for the motion echoed his belief as they believed that the economy has been suffering and that the result is disproportionate to the cost. Speakers speaking against the motion argued that this program is necessary to retain India's hegemonic status in the intense geopolitical condition that it is at the moment.

Both Best English and Hindi Speaker positions with a cash prize of Rs 3000 each were bagged by Jamia Millia Islamia University. The Best English team position with a cash prize of Rs. 10000 went to Aligarh Muslim University. The Best Hindi Team position went to Jamia Millia Islamia University. The rolling trophy with a cash prize of Rs.20000 of the 3rd Edition of Concours De Debat, 2019 which saw 56 speakers from various institutes clashing against each other,

was bagged by Jamia Millia Islamia University.
