# Activities at LCD

Faculty Development Program 2019-20 on Development of teaching skills with Advanced Research Techniques

An in-house program with an objective to provide the teaching faculty exposure and understanding of effective teaching pedagogies and apprise them of innovative teaching techniques was conducted between the  $20^{\text{th}}$  and  $26^{\text{th}}$  of July.

The 7 day event was convened by a galaxy of eminent contributors to the field of teaching in general and that of law in specific.



Prof. S.D Sharma, winner of President Awarding Research for the year 2017 and currently Dean of Law Department, Baba Saheb Bhimrao Ambedkar Central University presided over the inaugural session and emphasized on the role of the teachers in the development of any country and focused on "Pedagogy of Legal Teaching and Learning Centric" including the conceptual features of Traditional. Scientific and Technical methods and expressed that the teaching fraternity should be ready to accept the challenges by incorporating the contemporary ideas with a prudent application of judicious critical analysis

for a better learning outcome emphasizing on the substantial shift in the pedagogy of teaching from teacher centric to learner centric.



#### The second day on "Effective class Teaching: Role of Innovation and Incorporation of Ideas"

Was delivered by Prof. (Dr.) Rajesh Bahuguna, Principal and Dean of Law College Dehradun, who stated that every phenomenon is a teacher and there is no a precise definition or methodology, teaching being a dynamic process focused on the context and audience.



#### UNIFORM CIVIL CODE

During the British Rule, Indian Divorce Act was enacted; it applied to Christians only. Shariat Act was enacted and that applied only to Muslims. But when Constitution of India came into force, Art.13 and 15(1) were superimposed on them and the restrictions and prohibitions as found therein applied to them.

Civil Law is "A body of rules that delineate private rights and remedies, and govern dispute between individuals, in such areas as contracts, family law distinct from criminal law." "The word classification" may have two meanings, one primarily signifying a division required by statues, fundamental and substantial, and the other secondary, signifying an arrangement or enumeration adopted for convenience only."

#### **REFLECTIONS ON THE UNIFORM CIVIL CODE**

Religious fundamentalism must go, social and economic justice must be made available to the so-called minority and oppressed groups and their dignity should be ensured to achieve this dream of one India, one society and one Law.

Article 25 of the Indian Constitution says that the term 'Hindu' includes the Jain, Sikh and Buddhist communities despite the fact that Constitutional mandate reflects Hinduism in all the sects but we have framed the 'Anand Marriage Act' (Special provision for the Marriage for Sikhs). The basic question now lies how far this Act is constitutionally valid if under Art 44 we have incorporated a positive obligation upon the state to secure the Uniform Civil Code throughout the Country and at the same time we have enacted a legislation like this in contradiction with Art 25 of the Constitution of India.

In the light of above discussion we would like to suggest

- a. For the purpose of Article 25 of the Constitution the concept of religion should be defined confining it to the individual faith and belief and his personal relationship with his creator.
- b. A provision to Art. 29 (1) of the Constitution should be inserted to the effect that nothing contained in Sub Article 1 shall effect the operation of any existing law are prevent the state from making any law providing for social welfare or reform.
- c. The uniform civil code if it is to be drafted should not be voluntary but uniformly applicable to member of all the communities

If Muslim countries can reform Muslim laws and Western countries have a functional secular system, then what is the rationale behind the Indian Muslims being governed under the laws passed in the 1930s?

The debates in India have gone the way of the secularists and recent rulings of the Supreme Court calling for Uniform Civil Code has not witnessed the protests and alarms that took place following the Shah Bano case in 1985.
