

The participants for the FDP registered from almost 27 states of India making it a truly national event.



LCD VIRTUAL LEGAL EDUCATION-PROS & CONS

Dynamics of technological innovations has modified the learning-teaching process to a large extent and the ICT tools (Information & communication tools) have added value & validity to the learning process. The visual aids developed for presentation through the various modes of education has facilitated online learning adding value to the learning curve & enhancing the process of knowledge accumulation.

Legal education which ideally leads to a professional vocation of advocacy, soliciting or lawyering besides the judiciary is at the cross-roads for this profession demands a hands-on experience of the proceedings in the court of law and proactive interaction with the clientele.

The learning of law requires both a practical & theoretical knowledge of the various aspects of not only the traditional law but also of the contemporary legal domain including white collar crime, cyber crimes & cyber law, information technology laws, biotechnology laws, medical laws and intellectual property laws to name a few.

The advantages to the virtual and online legal education balance with the pitfalls or disadvantages, a learner of law or a to-be lawyer encounters in the process of legal education whether at the undergraduate or post graduate levels. The major challenge is that the practical aspects of law are not always met with during the course of learning as the real-time court room experience is an evident gap in the learning process for an advocate who is to be trained to be adept in the courtroom training and inter-personal relationships with the clients on one hand and the learned judiciary on the other.

The advantages of virtual sessions across the various online platforms be it Zoom, Microsoft Teams, CISCO Webex or Google Meet besides the customized ERP platforms of the various universities besides the comprehensive BLACKBOARD provide an opportunity to the teacher or resource person to deliver content effectively using the audio-visual aids while teaching. The students or the taught can put forth their point of view in a well-mannered and constructive way facilitating the two way learning process & the voice of the student is heard across the participants, sometimes across the international domains in virtual learning process.

The major advantage is the time saver on commute for the tutor and the taught do not have to travel to the universities or institutions for their lessons which are conducted from the comforts of their homes.

The virtual learning process contributes largely in enhancing and enriching the experience and logic building systems besides adding to the research process whereby the online resources for legal information is made available through the online legal databases such as Manupatra, Hein Online, Westlaw and SCC to name a few.

The student also gets access to detailed overview of the international legal framework through the case studies on the various challenges, concerns and changes to the legal and regulatory framework thereby facilitating a holistic global perspective and information. The process of attaining knowledge is facilitated by the access a legal educationalist has through the internet thereby being a value-add to the knowledge base at large.

The process of virtual legal education comes with the perks of easy learning but the major challenge is the practical application of the precedents, their interpretation and analysis that is a major learning curve to the case study critical analysis done through the offline mode of group discussions wherein the eye-contact, gestures and body-language at large, important and pertinent to the skill of advocacy take a back seat.

The advantage however is one doesn't have to rely on one particular member for information and different points of view and perspectives can be accessed for interpretation.

The pros and cons of virtual education balance their requirements in the legal education and for a traditional teacher the real education is where the reality lies and reasonable control of the classroom prevails for the sovereignty over the taught prevails.

[6th July, 2020]



NATIONAL WEBINAR ON “TRADEMARK LITIGATION: AN OVERVIEW OF CONCEPTS”


