


Competitions...

Legal Opinions...

Wildlife-human interaction – the legal framework and challenges

The relation between humans and animals share a unique kind of bond "the mutualism" where both are benefited from the alliance of being joined together. Artificial Intelligence and Legal Challenges–a perspective

The development of full artificial intelligence could spell the end of Human race- Stephen Hawking

The age of Artificial intelligence is dawning with time machines mimicking the humans in contemporary times.

Russian President Vladimir Putin in his speech expressly mentioned that the nation that has mastery on AI will rule the world.

А 2016 Report issued by Obama administration defines AI loosely as a computerized system that exhibits behavior that is commonly thought of as intelligence while others define it as a system capable of solving complex problems. In 2018 Microsoft defines it as "a set of technologies that enable computers to perceive, learn, reason and assist in decision making to solve problems in ways that are similar to what people do." The legal challenges of AI which lead the legal fraternity to amend and draft new laws to meet the dynamics of the emerging technologies of AI include areas of copyright violation and infringement, execution and performance of contracts along with international contracts involving letter of credit and bills of lading in trade

relations and transactions, the personhood of a legal entity, the effectiveness of the tort laws, dynamics of laws related to crime and punishment, human rights and their violation and vulnerabilities of the cyber space and security besides others.

Drug Laws in India-the much requisite amendments

The drug laws in India are governed by the Narcotics Drugs and Psychotropic Substances Act, 1985 which came in to force on 14th November 1985. The Act aimed to curtail the possession, consumption, distribution, sale and import of the most addictive drugs known to mankind and impose deterrent punishments for anyone who committed any offence under the Act.

Before the NDPS ACT was passed by the Parliament, the laws relating to drugs could be traced way back to the Opium Act, 1857 which was followed by the Opium Act, 1878 and the Dangerous Drugs Act, 1930. The provisions under these statutes were not very regulated and contained very small punishments for the offences relating to drugs.

After International peace treaty called the Single Convention on Narcotic Drugs, 1961 various signatory countries to the convention i.e. the United States of America and the United Kingdom adopted a stricter approach towards curbing and getting control over the drugs menace in these countries.

With the rise in International standards and awareness, India considered the need to incorporate these measures in the form of legislation that would serve the purpose in the domestic sphere. Hence, the 'National Drugs and Psychotropic Substances Act' was enacted in 1985. The Act classifies drugs into small, less than commercial and commercial and lists punishments based on this classification. The enactment includes substances obtained from nature such as Ganja (Marijuana) along with narcotic and psychotropic drugs.

As per the criminal jurisprudence system in India the accused is innocent until proven guilty which is contrary to the provisions and spirit of the NDPS Act. It is contrary to the standard principles of Human rights as it particularly holds the accused guilty until proven innocent and puts the onus to prove their innocence on the accused. Under the Act unless the contrary is proved, the courts will believe that the accused intentionally held the illicit drugs that were found in this possession.

Recent legal perspective and liability in medical practice- lacunae in the medicolegal laws in India The laws of medical practice in India are confined to the Criminal Procedure Code and the Civil Procedure Code depending on the negligence which is considered most often as a tortuous liability on the part of the practicing medical profession whilst it ought to have a serious implication and responsibility on the medical practitioner.

The medical and ethical council of India provides for the guidelines and rule book for the practicing medical professionals, whether on the surgical or non-surgical areas of treatment. The medical professional fails most often than not, and many a time chooses to ignore the ethical and moral standards one ought to follow, as there are primarily no strict laws focusing on the various degrees of liability that а professional may be subject to. Many a time, the doctors take advantage of the ignorance, poverty and lack of medical knowledge on the part of an average Indian and the examples of such are galore.

Diagnostics, prognosis, treatment, surgical or non-surgical, post-operative care or follow-up visits of the patients are certain aspects that are being misused by many a registered medical practitioner not to mention the quacks and their gimmicks in providing treatment from an ailment.

An insight into the legal perspective of the medical profession in India with various decided cases of medical and clinical negligence, medical malpractice and medical ignorance, leading to the victimization of the patients who are affected both in physical health coupled with mental trauma owing to the scrupulous ways of the noble medical professional is the call of the hour.

It is hence pertinent and essential to bring forth the need for the Indian medical laws to adhere and adapt to international standards in medical care, hospital administration, clinical trials and diagnostics in both the government and private sectors, across the various strata of clinics, hospitals and public health care centers in the country.
