I sincerely am grateful to my fraternity who have risen to the situation and set the ball rolling to ensure LCD shall perform against adversity.








14th October 2022 National webinar on "Wealth Creation through Personal Finance Management"

The Changing Role of Police Administration in India

16th November 2022, Competition Cell, Law College Dehradun of Uttaranchal University organized "Administration Then and Administration Now: The Changing Role of Police Administration In India" by the eminetkeynote speaker Dr. Kiran Bedi, Retd. IPS officer & former Lt. Governor of Pondicherry.

She is the first woman in India to join the officer rank of the Indian Police Service in 1972 and was the 24th lieutenant governor of Puducherry from 2016 to 2021.Dr. Kiran Bedi began her presentation by shedding some light on the subject, displaying data on the state of manpower, technology, units, training, and women between January 1986 and January 2021 as we can see there is a big change in the number of sanctions strength. She also mentioned about the strength of CAPFs which has also increased to 11,09,969 from 3,31,989. She emphasised on the gender related issues that have decreased in the last three decades and highlighted the new emerging challenges like financial crime, cybercrimes, and cyber security and the growing importance of Information technology. The enlightening session concluded with a vote of thanks delivered by The Chairperson Assistant Prof. Sachin Kumar.







6th December 2022, SRIJAN 6.0 by The Rotaract Club, Law College Dehradun faculty of Uttaranchal University on the socio-legal discussion "Exclusion ST/SC/OBC of categories from EWS quota a violation of the basic structure or a step forward towards taking an affirmative action to combat poverty in India". 8 student bodies took part in the discussion. In a tough contest, Ms. Satakshi Sharma and Amrit Raj Dubey were declared winners and Runner-up respectively by the judges.



5th September 2022 NATIONAL ARTICLE WRITING COMPETITION 3.0






















Legal Opinions...

SILENCE AS A POWER AND A RIGHT

"In the sweet territory of silence we touch the mystery. It's the place of reflection and contemplation, and it's the place where we can connect with the deep knowing, to the deep wisdom way."

 Angeles Arrien quoted in The Millionth Circleby Jean Shinoda Bolen

Silence is both powerful as well as a significant quality and a weapon that an individual can posses. The first skilltaught in the path of spirituality and meditation of any form is to master the art of being calm and silent. It is often preached by monks that "the challenge is to find calm in the crowd" and "god gave us two ears but a single mouth".

Modern day therapies also focus on meditation techniques and there is no denial of the fact that meditation is gaining a lot of popularity. A silent person preserves a lot of energy is another inescapable truth. The Constitution of India, 1950 guarantees to every citizen the right to freedom of speech and expression (Article 19(1)(a)). However, it should be noted that the right to freedom of speech and expression includes the right to remain silent (Bijoe Emannuel v. State of Kerala). Further, Article 20(3) of The Constitution of India, 1950protects an accused against selfincrimination. In *Sujit Biswas v. State of Assam*, the honorable Supreme Court of India held that "the accused has the right to remain silent, as he cannot be forced to become a witness against himself".

Another noteworthy provision which provides the right to remain silent to an accused is section 313(3) of CrPC.

The intricate nexus of Intellectual Property rights, Information Technology and legal framework

The widespread availability of digital technology has allowed for the dissemination of information at a rateand with a degree of accuracy that was before impossible.

The extensive use of the Internet and other types of electronic media have shown to be a successful and efficient technique of distribution when it comes to spreading works of literature, art, or science to a large audience.

On the other hand, it prompts several issues that need to be considered some of which include the following:

- I. Whether or not digitalization is analogous to replication?
- II. Is the process of digitising anything similar to the logical process of translating from one language to another?
- III. Should commercial distribution or public communication like broadcasting of digital materials through the Internet be considered?

- IV. Is the exhaustion of the distribution right concept still relevant in the information age?
- V. Is it reasonable to see a database as a particular collected work deserving of copyright protection, or is it more reasonable to treat it as a special work that requires special laws for its preservation?
- VI. What does "Faire usage" mean in the context of the World Wide Web?
- VII. What are the record keeping patrons worried about?
- VIII. How can the public practise fair usage with respect to such works in the digital arena if the copyright owner may technologically limit access?
- IX. Should record keepers be barred from using digital technology to create three copies (an archive copy, a master copy, and a use copy) to ensure the longevity of works?
- X. Whether or not organisations that provide Internet access (such as schools and corporate offices) should be held legally responsible for a user's violation of another's intellectual property rights simply because they enabled the transfer of digital data (binary digits) that ultimately became that creator's copyrighted creation.

All these are unique to the internet world and are we as the legal fraternity prepared to combat them effectively?
