

Seminar on Uniform Civil code, August 12, 2023

Mr. Vikramjit Banerjee, Additional Solicitor General of India and Senior Advocate of the Supreme Court, was present on the occasion as the Chief Guest and Hon'ble Mr. Justice Lokpal Singh, (Retd.) from the Uttarakhand High Court was the Guest of Honor.

Justice (Retd) Shri Lokpal Singh remarked that starting from the Constituent Assembly of India and in support of Articles 12, 14, 21, the implementation of Uniform Civil Code by the state of Uttarakhand is a good example first to protect the rights of women. He gave priority to the rights of women



over different religions, sects and personal laws.

The Chief Speaker of the program and the Additional Solicitor General of India said that even after 75 years of independence, the debate on Uniform Civil Code is shameful and protection of women's rights is necessary for the creation of New India. He further said that we should also take care of the five thousand years old customs and traditions so that the acceptance of Uniform Civil Code can be made among the Schedule Castes and Tribes

The laws of medical practice in confined India are the to Criminal Procedure Code and Civil Procedure Code the depending on the negligence which is considered most often as a tortuous liability on the part of the practicing medical profession whilst it ought to have a serious implication and responsibility on the medical practitioner.

The medical and ethical council of India provides for the guidelines and rule book for the practicing medical professionals, whether on the surgical or non-surgical areas of treatment. The medical professional fails most often than not, and many a time chooses to ignore the ethical and moral standards one ought to follow, as there are primarily no strict laws focusing on the various degrees of liability that a professional may be subject to. Many a time, the doctors take advantage of the ignorance, poverty and lack of medical knowledge on the part of an average Indian and the examples of such are galore.

Diagnostics, prognosis, treatment, surgical or nonsurgical, post-operative care or follow-up visits of the patients are certain aspects that are being misused by many a registered medical practitioner not to mention the quacks and their gimmicks in providing treatment from an ailment.

This calls for an aim to provide an insight into the legal perspective of the medical profession in India with various decided cases of medical and clinical negligence, medical malpractice and medical


Medical negligence may be lucidly understood if the actual concept of negligence, most often considered a tortuous liability is clearly comprehended.
