



The emergence of technologically advanced means and modes for conducting research has created a lacuna for traditional teachers and legal researchers, right from the conduct of empirical research to the review of the literature using modern tools, and reliable and authentic literature resources. The FDP has a focused three-fold objective to ensure legal databases are accessed with optimal utilization of the e-resources, effective writing of research papers and proposals with an understanding of the aspects of copyright issues and violations.

The inaugural session had the customary traditional lighting of the lamp by Prof (Dr) Rajesh Bahuguna, Dean, Law College Dehradun, and Pro Vice-Chancellor Uttarakhand University along with Prof (Dr) Poonam Rawat, Principal, Law College Dehradun, and the team DIQAC. The speaker on the opening day was Mr Abijeet Gupta from Lexis Nexis who trained on Legal Research Beyond Cases and the use of the e-resources

available at the University followed by Mr Arun Singh Thakur, Senior Grade Librarian at Uttarakhand University appraising the genuineness and Authenticity in Research, use and misuse of Legal Resources, and effective use of Library for Legal Research and Publication.






Given the rate at which divorces are increasing in India, Pre-Marital counseling is absolutely necessary. The decline in the teachings of values given in families is also largely responsible for this. A counseling session was also taken by the former district judge. At the end a question-answer session was held.

March 6, 2024

A district level workshop was organized today at Law College Dehradun of Uttaranchal University under the joint aegis of PC-PNDT Cell of Dehradun district and Law College Dehradun. Secretary of District Legal Services Authority, Mr. Harsh Yadav was present on this occasion as the chief guest while Chief Medical Officer of Dehradun, Dr. Sanjay Jain was present as a special guest. ## Seminar on The Role of Forensic Science in Criminal Investigation

May 7, 2024

A seminar was organized at Law College Dehradun of Uttarakhand University on 'Role of Forensic Science in Criminal Investigation'. Dr. G.K. Goswami, Additional Director General of Police of Uttar Pradesh and Director of Forensic Science Institute, Lucknow, was the chief guest and keynote speaker on this occasion. More than 1200 participants from various departments were present in the seminar.

Shri Goswami ji explained the rationale and importance of forensic science by sharing his police service experiences in very simple words. He stated that the edifice of every dispute is established on the foundation of injustice whereas justice is at the core of forensic science. He said “the common man expects a fair hearing from the court, but the reality is that a fair hearing is not possible without fair investigation. A verdict based only on oral testimony is not a guarantee of justice whereas evidence based on forensic science not only adds weight to the main evidence but is also impartial and scientifically tested.” He emphasised on the importance of forensic science as a powerful weapon which is capable of proving both guilt and innocence.

Prof. Rajesh Bahuguna, Dean of Law College and Pro Vice-Chancellor of University said that the Bharatiya Nagarik Suraksha Sanhita, 2023 has now made forensic investigation

mandatory in cases of offences having punishment of more than seven years. Due to this, the importance of forensic science has increased and immense possibilities have emerged in this field. Vice Chancellor of the University, Prof. Dharam Buddhi delivered vote of thanks and proposed an MoU with the Institute of Forensic Science, which Shri Goswami ji gladly accepted.

## Exam Paper Leaks: Collapse of a Nation

With the breaking of news of paper leak of NEET exam which is conducted by NTA, the student as well as aspirant community is grappled with fear about uncertainty of their future. Few months before, the recruitment exam for Review Officer conducted by UPPSC was also sabotaged by leak of question paper which led to widespread discontent against the Public Service Commission. The recruitment drives conducted by Rajasthan PSC are notoriously famous for security breaches as regards the secrecy of question papers. High Court of Judicature at Allahabad is currently hearing a case about alleged irregularities in PCS-J exam where response sheets of Mains exam of many candidates were found to be torn apart. Most recent case of IAS Pooja Khedkar and the consequent fiasco resulting in resignation of Chairman of Union Public Service Commission has shown that UPSC too is not so sacrosanct as it is believed to be.

These cases are only the tip of iceberg. Many such cases remain buried in the layers of widespread corruption inflicting immense damage to the nation. The candidates who get selected

through these exams form steel-framework of Indian bureaucracy & service class. These selected candidates enjoy the confidence of large section of populace because of the faith of the masses in the integrity of these exams. This faith is now dwindling at a rapid pace. Imagine a situation where you go to a hospital for being treated for an ailment and doctor in charge is a candidate who got through NEET by fraud & cheating. Or a situation where you are fighting a legal battle in court of law for a matter of life & death and presiding judge is a person who got through PCS-J exam through collusion with the officials of Public Service Commission. Yes, nobody wants to find himself/herself going through such a spine-chilling experience.

It is now imperative that the government agencies entrusted with responsibility to conduct these exams take stock of the prevailing situation. A meritocratic nation is built upon the edifice of transparent and trustworthy examination process. The prevailing examination scene in the country needs a complete overhaul which can be done by introduction of reforms. Now it is upon the government to redeem itself from such a problematic situation and rise up to the demand of an aspirational society.

## Role of Indian Constitution to accomplish Climate Justice

An urgent international environmental concern is climate change. Anthropogenic activities are to blame for climate problems. In addition to legal considerations, climate change also creates challenges related to scientific, social, economic, political, and cultural factors. The "defining concern of our generation," according to UN Secretary General Ban Ki-moon in 2014, was climate change. Literature also claims that prospects for a "new, low-carbon economy and a new, resilient society" have arisen because of climate change. To address climate concerns in a sustainable manner, it is crucial to develop a climate justice route where nations take a practical approach to solving climate challenges.<sup>1</sup>

India placed fifth internationally in terms of vulnerability to climate impacts due to having the most climate-related deaths in 2018. India has also been placed first in terms of fatality hazards and second in terms of economic risks. Also, the recent heat waves are endangering the health and way of life of the nation's most vulnerable citizens. According to a recent study, the poor in other nations including Japan, the Philippines, Germany, and Madagascar are also more vulnerable to the effects of climate change than those in India. Climate

dangers might cause the nation's already widening disparities.

Through funding systems for adaptation and mitigation, the UNFCCC has helped India take climate action. The National Bank for Agricultural and Rural Development (NABARD) has been recognised by the Green Climate Fund as the National Implementing Entity in this respect (NIE). The NIE is qualified to obtain grants, loans, and other facilities with favorable terms. Only when the top polluters can attain zero emissions levels and when emerging countries like China and India are able to define their sustainable urban futures will the effectiveness of the global climate pledges be assessed. The concessions that should be made to serve national interests will continue to be a topic of discussion among nations. They must be reported on and reviewed on a regular basis to make sure the objectives are met.
