Ph.D. Admission (Summer Batch: 2025-2026)

Applications are invited from eligible candidates for admission to the Ph.D. programmes in various disciplines for the Summer Batch: 2025-2026, in accordance with the UGC Ph.D. Regulations, 2022.

An Entrance Examination (UURET) for Ph.D. Programmes will be conducted on 26th July, 2025. UURET consists of written examination followed by interview. Qualified candidates (from UURET written test) will be called for interview.

Valid Score of UGC-NET/CSIR-NET/GATE/CEED/GPAT will be considered in place of written test, but they will have to appear in Interview.

Priority will be given to NET/similar national level test qualified candidates. Online/offline applications received up to 20th July, 2025 will be considered for entrance exam.


