Winter Batch: Academic Year 2024-2025

Admission will be based on valid scores from UGC-NET/CSIR-NET/GATE/CEED exams. For candidates who have not qualified or appeared in these examinations, an Entrance Examination of the University will be conducted.

University Entrance Examination is scheduled for the 02nd week of January, 2025 (proposed date: 11th January, 2025).

Entrance Examination consists of written examination followed by interview. Qualified candidates will be called for interview.

Candidates with valid UGC-NET/CSIR-NET/GATE/CEED scores do not need to take the written exam but must appear for the interview. Final selection will be based on the basis of total marks scored in written (NET score or Entrance Examination) and Interview. Weightage of written exam/NET score will be 70% while 30% weightage will be for interview. Priority will be given to NET qualified candidates.
